- Submitting demolition proposal to the Building Authority for agreement before (a) commencement of any works; and
- (b) Upon completion, certifying that the agreed works have been carried out in accordance with the provisions of the Buildings Ordinance and regulations made thereunder.

You are required under the Buildings Ordinance to appoint a Registered Specialist Contractor in the demolition category to carry out the works, and an Authorized Person to advise on the necessary safety measures and to ensure the provision of those measures.

5 You are required to commence the works ordered by me in paragraph 2 above within 90 days and complete such works within 180 days of the date of this order, all to the satisfaction of the Building Authority.


