Explanatory Note Paragraph 1

L.N. 165 of 2020 B2949

Explanatory Note

This Regulation amends the United Nations Sanctions (South Sudan) Regulation 2019 (Cap. 537 sub. leg. CK) (*principal Regulation*) to give effect to certain decisions in Resolution 2521 (2020) adopted by the Security Council of the United Nations on 29 May 2020.

- 2. Section 2 of this Regulation amends section 2 of the principal Regulation to provide that sections 3, 4, 5, 6, 7, 9 (as amended by this Regulation), 10 and 11 of the principal Regulation (*relevant provisions*) are in force only until midnight on 31 May 2021.
- 3. The relevant provisions relate to the prohibition against—
 - (a) the supply, sale, transfer or carriage of arms or related materiel to South Sudan;
 - (b) the provision of technical assistance, training or financial or other assistance related to military activities in certain circumstances;
 - (c) making available to, or for the benefit of, certain persons or entities any funds or other financial assets or economic resources:
 - (d) dealing with funds or other financial assets or economic resources belonging to, or owned or controlled by, certain persons or entities; and
 - (e) entry into or transit through the HKSAR by certain persons.
- 4. This Regulation also makes certain minor textual amendments.
