

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 16)

PWP ITEM NO. 6579TH  
CREATION OF RIGHTS OF TEMPORARY OCCUPATION OF LAND FOR  
CENTRAL—WAN CHAI BYPASS AND ISLAND EASTERN CORRIDOR LINK

TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 15(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') directing that rights of temporary occupation for a further period commencing from 1 January 2021 (i.e. the day immediately after the expiry of the period referred to in Government Notice No. 5968 dated 26 September 2019) to 31 December 2021 be created over portion of each of the following pieces or parcels of land known and registered in the Land Registry as:—

The Remaining Portion of Marine Lot No. 277 and the Extension thereto  
The Remaining Portion of Marine Lot No. 281 and the Extension thereto  
The Remaining Portion of Marine Lot No. 293 and the Extension thereto  
The Remaining Portion of Inland Lot No. 7106 and the Extension thereto

as shown coloured purple stippled black on the Plan No. HKM8140b annexed to the said order which said respective portions of the said respective pieces or parcels of land were described in the scheme referred to in Government Notice No. 4767 published on 27 July 2007 and 3 August 2007 as amended by Government Notice No. 8202 published on 5 December 2008 and 12 December 2008, Government Notice No. 3775 published on 14 June 2019 and 21 June 2019 and Government Notice No. 6266 published on 11 October 2019 and 18 October 2019 (hereinafter referred to as 'the said scheme').

The Deputy Director/Specialist, Lands Department has under section 15(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 15(5) of the Ordinance, the Director of Highways, his officers, workmen, servants, contractors and any other persons authorized or permitted by the Director of Highways are authorized to enter upon the said respective portions of the said respective pieces or parcels of land for the purposes of or incidental to the works or use described in the said scheme and for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus in connection with the said scheme.

The Deputy Director/Specialist, Lands Department has under section 15(2) of the Ordinance specified a period of notice starting from 24 September 2020 on which this notice was affixed on or near the said respective portions of the said respective pieces or parcels of land and expiring at mid-night on 31 December 2020.

It is hereby declared that upon expiry of that period, the aforesaid rights of temporary occupation over the said respective portions of the said respective pieces or parcels of land shall by virtue of section 15(4) of the Ordinance be created in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or use described in the said scheme.

Any person owning a compensatable interest under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date on which the aforesaid rights of temporary occupation are created:—

- (1) By post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is obligatory. If such information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data in relation to their claims.
