ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

ADVANCE SITE FORMATION AND ENGINEERING INFRASTRUCTURE WORKS
AT KWU TUNG NORTH NEW DEVELOPMENT AREA AND
FANLING NORTH NEW DEVELOPMENT AREA (ROAD WORKS)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways of On Kui Street, at grade footpaths/accesses of On Kui Street and Sha Tau Kok Road (Lung Yeuk Tau) and cycle tracks of Sha Tau Kok Road (Lung Yeuk Tau) within the limit of works area as shown on Plans Nos. 60335576/GZ1/100, 60335576/GZ1/109 and 60335576/GZ1/110 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 60335576/GZ1/100A, 60335576/GZ1/LEGEND, 60335576/GZ1/109A and 60335576/GZ1/110A ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 10021 published on 31 December 2015 and 8 January 2016. The Amendment Plans and amendment scheme were referred to in G.N. 6487 published on 18 November 2016 and 25 November 2016. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 27 September 2020 to 26 September 2021, all public or private rights in, upon, under or over the sections of the existing at grade carriageways of On Kui Street, at grade footpaths/accesses of On Kui Street and Sha Tau Kok Road (Lung Yeuk Tau) and cycle tracks of Sha Tau Kok Road (Lung Yeuk Tau), to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly relate to the reprovision of North District Temporary Wholesale Market for Agricultural Products and associated engineering infrastructure works.

This notice will be affixed on or near the affected at grade carriageways, at grade footpaths/ accesses and cycle tracks on 25 September 2020.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
