- a) Complete the prescribed inspection and, if necessary under section 30C(6) of the Buildings Ordinance, the prescribed repair within 6 months of the date of this notice.
2. The prescribed inspection and, if necessary, prescribed repair must be carried out in accordance with the provisions of the Buildings Ordinance and its related Regulations including the Building (Inspection and Repair) Regulation.
3. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any notice, such power shall include power to substitute another notice for the one already made. Pursuant to that section, the Building Authority who is empowered under section 30C(4) of the Buildings Ordinance (Cap. 123) to make the previous notice i.e. Notice No. **UMW/SOF101/1701-358/0007** dated **2 August 2018** is also empowered to make this notice which substitutes the previous notice.
