

ROAD TRAFFIC (TRAFFIC CONTROL) REGULATIONS (Chapter 374)

TEMPORARY RESTRICTED ZONES IN KOWLOON BAY

In exercise of the powers vested in me under regulation 14(1)(b) of the Road Traffic (Traffic Control) Regulations, Chapter 374, I hereby direct that with effect from 1 October 2020 to 31 December 2020, the following road sections in Kowloon Bay will be temporarily designated as restricted zones 24 hours daily:—

- (a) the section of Shing Cheong Road from its junction with Cheung Yip Street to its junction with Kai Tak Bridge;
- (b) the section of Cheung Yip Street from its junction with Lam Chak Street to a point about 120 metres north of the same junction;
- (c) the section of Cheung Yip Street from its junction with Lam Chak Street to a roundabout about 190 metres south of the same junction;
- (d) the section of Lam Chak Street from its junction with Cheung Yip Street to a point about 30 metres east of the same junction;
- (e) a section of an unnamed road from the roundabout located at about 190 metres south of the junction of Cheung Yip Street and Lam Chak Street to a point about 10 metres west of the abovementioned roundabout;
- (f) a section of an unnamed road from the roundabout located at about 190 metres south of the junction of Cheung Yip Street and Lam Chak Street to a point about 10 metres east of the abovementioned roundabout;
- (g) a section of an unnamed road from a point about 50 metres west of the junction of Shing Cheong Road and Cheung Yip Street to a point about 10 metres south of the abovementioned starting point;
- (h) a section of an unnamed road from a point about 210 metres west of the junction of Shing Cheong Road and Cheung Yip Street to a point about 15 metres south of the abovementioned starting point;
- (i) a section of an unnamed road from a point about 180 metres west of the junction of Shing Cheong Road and Cheung Yip Street to a point about 10 metres north of the abovementioned starting point;
- (j) a section of an unnamed road from a point about 20 metres north of the junction of Cheung Yip Street and Lam Chak Street to a point about 10 metres west of the abovementioned starting point; and
- (k) a section of an unnamed road from a point about 40 metres south of the junction of Cheung Yip Street and Lam Chak Street to a point about 10 metres west of the abovementioned starting point.

Within the restricted zones, drivers of all motor vehicles, except franchised buses and those with permits issued by the Commissioner for Transport, will be prohibited from:—

- (a) picking up or setting down passengers; or
- (b) loading or unloading goods.

The extent of the restricted zones has been indicated by appropriate traffic signs and road markings.
