It is hereby notified that sealed tenders are invited for two 36-months term contracts—Buildings Department Works Contract (Kowloon and New Territories) Contract No. 1/BD/2021 and Buildings Department Works Contract (Hong Kong) Contract No. 2/BD/2021. The works include, but not limited to, building repair, demolition, drainage, slope remedial/preventive works, investigation and emergency works.

Separate and sealed envelopes for Technical Submission(s) and Tender Price Document of the tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and deposited in the Government Secretariat Tender Box ('Specified Tender box') situated in the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 13 November 2020. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted. If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on 13 November 2020 (Friday), the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on 13 November 2020 (Friday), the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made *via* press releases on the website of Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Selective tendering is adopted. Contractors who meet all of the following requirements are invited to tender:—

- be a Group B Contractor under Buildings Category in the List of Approved Contractors for Public Works and a Registered General Building Contractor under the Buildings Ordinance (Chapter 123);
- be able to demonstrate the ability in entering into a written sub-contract with a contractor who is a Registered Specialist Contractor in the category of Demolition Works under the Buildings Ordinance (Chapter 123);
- be able to demonstrate the ability in entering into a written sub-contract with a contractor who is a Registered Specialist Contractor in the category of Foundation Works under the Buildings Ordinance (Chapter 123);
- be able to demonstrate the ability in entering into a written sub-contract with a contractor who is a Registered Specialist Contractor in the category of Site Formation Works under the Buildings Ordinance (Chapter 123) and at the same time is enlisted on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Landslip Preventive/Remedial Works to Slopes/Retaining Walls Category;

- (e) completed at least one (1) public or private construction contract for building or building maintenance works of contract value of not less than HK\$56.8M for 1/BD/2021 and not less than HK\$40.4M for 2/BD/2021 in the past 5 years counting from the original date set for the close of tender; and
- (f) having less than 10% performance reports for contracts under the category of Buildings in the record of Development Bureau rated as 'adverse' in the 5-year period which ends on 31 August 2020.

The requirements for item (b), (c) or (d) above will be considered met by the Tenderer if the Tenderer possesses the same qualifications stipulated therein. Contractors will be liable to have their names removed from the List of Approved Contractors for Public Works if they fail or refuse to implement an accepted tender.

A pre-tender briefing session will be held before the tender closing date. Please refer to tender documents for details.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender with the highest overall score.
