

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. YL/2020/03—Hung Shui Kiu/Ha Tsuen New Development Area Stage 1 Works—Site Formation and Engineering Infrastructure**. The works mainly include:—

- (i) site clearance and formation (including land decontamination works) for about 14 hectares of land, together with the provision of associated engineering infrastructure;
- (ii) construction of a district distributor road of about 500 m long, which is a dual two-to-three-lane carriageway connecting to the existing interchange underneath Kong Sham Western Highway, construction of a single two-lane local roads of about 350 m long, widening of a section of Fung Kong Tsuen Road to single two-lane carriageway of about 150 m long and associated junction/road improvements;
- (iii) construction of about 1 700 m long sewer, about 360 m long sewage rising mains and a sewage pumping station (including electrical and mechanical works);
- (iv) construction of about 1 700 m long drainage pipes and associated detention pond;
- (v) construction of about 2 300 m long water mains; and
- (vi) implementation of environmental mitigation measures, environmental monitoring and audit programme for the works mentioned above.

The works are scheduled to commence in March 2021 and will take about 60 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 18 December 2020. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 18 December 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 18 December 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Site Formation Category or the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C under the Site Formation Category or the Roads and Drainage Category who also meet the following qualifications and conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving site formation works or roads and drainage works, with an adjusted contract value of not less than HK\$260 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Site Formation Category and/or the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 13 November 2020 to Chief Engineer/West 3, West Development Office, Civil Engineering and Development Department, on 9th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
