(Notice of authorization under section 9)

CONSTRUCTION OF PUBLIC LANDING FACILITY AT
TUEN MUN AREA 27 BREAKWATER

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 4366 published under section 5 on 31 July and 7 August 2020 was authorized under section 7 on 21 October 2020.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 3 780 square metres of foreshore and sea-bed situated near Tuen Mun Area 27 Breakwater in Castle Peak Bay as delineated and shown edged red on a plan, numbered TMM4207a, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Construction of a public landing facility at Tuen Mun Area 27 Breakwater in Castle Peak Bay. The proposed public landing facility will include a gangway and a floating platform held in position by piles. It will cover an area of approximately 180 square metres above the sea.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters.
