SCHEDULE

Foreshore and sea-bed affected

Approximately 1.33 hectares of foreshore and sea-bed situated to the north of Lai Chi Chong as delineated and shown edged red on a plan, numbered TPM6537, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include demolition of the existing Lai Chi Chong Pier, construction of a new pier and provision of a temporary pier during the construction stage. The proposed pier will be composed of a suspended deck founded on piles, a gangway, and a floating platform held in position by piles. It will cover an area of approximately 800 square metres above the sea.
