

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1938EM20T—Quadrennial Term Contract for Provision of Maintenance and Modification Works for TD142 Closed Circuit Television System for Transport Department**. The scope of the Works includes provision of maintenance service and modification works for TD142 Closed Circuit Television System. The Contract is scheduled to commence in February 2021 for expiry in January 2025.

Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 18 December 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
