Amendments under section 7

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to amend the works and the use originally shown on Plans Nos. 91272/GAZ/1000 to 91272/GAZ/1007 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 43 published under section 8(2) of the Ordinance on 3 January 2020 and 10 January 2020.

The proposed amendments are shown on the Amendment Plans Nos. 91272/GAZ/2100 to 91272/GAZ/2106 ('the Amendment Plans') and described in the amendment scheme annexed thereto. The part of the Works and the Use proposed for amendment shown on Plans Nos. 91272/GAZ/2000 to 91272/GAZ/2006 annexed to the Amendment Plans are for reference only. The Amendment Plans, amendment scheme and Plans Nos. 91272/GAZ/2000 to 91272/GAZ/2006 have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:—

- (a) Amendment A (as shown on the Amendment Plan No. 91272/GAZ/2101):—
- (i) revision of the originally proposed limit of works area;
 - (ii) revision of the layout of the originally proposed carriageways, footpaths, central median/refuge island, amenity area, slope improvement works and retaining walls near Pak Wai;
 - (iii) deletion of the originally proposed slope improvement works adjacent to the southbound carriageway next to the proposed retaining wall near Pak Wai; and
 - (iv) addition of noise barrier at the southbound carriageway near Pak Wai.
- (b) Amendment B (as shown on the Amendment Plan No. 91272/GAZ/2102):—
- (i) revision of the originally proposed limit of works area;
 - (ii) revision of the layout of the originally proposed carriageways, footpaths, central median/refuge island, amenity area, subway, lift and retaining wall near Pak Sha Wan Street; and
 - (iii) revision of the layout of the originally proposed carriageway, footpath and retaining wall near Kau Sai Sun Tsuen Road.
- (c) Amendment C (as shown on the Amendment Plan No. 91272/GAZ/2103):—
- (i) revision of the originally proposed limit of works area;
 - (ii) revision of the layout of the originally proposed carriageways, footpaths, central medians/refuge islands, amenity area, slope improvement works and retaining walls near Tai Chung Hau Road;
 - (iii) deletion of the originally proposed slope improvement works near Mang Kung Wo Road and replacement by proposed carriageway;
 - (iv) deletion of slope improvement works near Tai Chung Hau Road and replacement by proposed retaining wall; and
 - (v) addition of slope improvement works near Mang Kung Wo Road.
- (d) Amendment D (as shown on the Amendment Plan No. 91272/GAZ/2104):—
- (i) revision of the originally proposed limit of works area;
 - (ii) revision of the layout of the originally proposed carriageways, footpaths, central medians/refuge islands, amenity areas, slope improvement works, noise barrier and retaining walls near Che Keng Tuk Road;

- (iii) revision of the layout of the originally proposed carriageway, footpath and slope improvement works near Pak Kong Road; and
 - (iv) addition of noise barriers and retaining walls near Pak Kong Road.
- (e) Amendment E (as shown on the Amendment Plan No. 91272/GAZ/2105):—
- (i) revision of the originally proposed limit of works area;
 - (ii) revision of the layout of the originally proposed carriageway, footpath and central median/refuge island near Po Lo Che Road;
 - (iii) revision of the layout of the originally proposed footpath and retaining walls near Sun On Tsuen;
 - (iv) deletion of the originally proposed slope improvement works near Po Lo Che Road and replacement by proposed carriageway, footpath and central median/refuge island;
 - (v) deletion of the originally proposed slope improvement works near Hong Kin Road;
 - (vi) deletion of a section of the originally proposed slope improvement works near Sun On Tsuen;
 - (vii) deletion of a section of the originally proposed noise barrier near Sun On Tsuen; and
 - (viii) addition of retaining walls near Po Lo Che Road and Hong Kin Road.
- (f) Amendment F (as shown on the Amendment Plan No. 91272/GAZ/2106):—
- (i) deletion of a section of the originally proposed noise barrier adjacent to the northbound carriageway near The Mediterranean; and
 - (ii) addition of a section of noise barrier adjacent to the southbound carriageway near The Mediterranean.
- (g) deletion of the originally proposed resumption of lots in respect of the following:—

- (h) revision of the areas of land proposed to be resumed in respect of the following:—

- (i) revision of the originally proposed ancillary works including landscaping, drainage, lightings, electrical and mechanical works; implementation of environmental mitigation measures and provision of traffic aids.

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed amendments in his notice of objection. Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes.
