Foreshore and sea-bed affected

Approximately 7 880 square metres of foreshore and sea-bed situated at the inner estuary between Kau Sai Chau and Tiu Chung Chau as delineated and shown edged red on a plan, numbered SKM9717a, deposited in the Land Registry. Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include demolition of the existing Kau Sai Village Pier, construction of a new pier and provision of a temporary pier during the construction stage. The proposed pier will be composed of a suspended deck founded on piles, covering an area of approximately 400 square metres above the sea.
