SCHEDULE

Foreshore and sea-bed affected

Approximately 0.24 hectares of foreshore and sea-bed situated at the northern end of the existing Tai Po Railway Pier as delineated and shown edged red on a plan, numbered TPM6554, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include demolition and reconstruction of the existing tide gauge station and part of the existing pier structure. The reconstructed tide gauge station and part of pier will be founded on piles, and will cover an area of approximately 24 square metres above the sea, which is equivalent to the sea area covered by the existing station and part of pier.
