

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS H506—Construction of Lung Tsun Stone Bridge Preservation Corridor at Kai Tak (Programme No. 470RO)**.

The works include in-situ preservation of the Lung Tsun Stone Bridge remnants and construction of a preservation corridor for public appreciation and leisure purpose comprising archaeological works, conservation treatment, provision of interpretation facilities, open space with a continuous traffic-free pedestrian walkway along the corridor, landscaped areas with benches and pavilions and ancillary facilities, together with building services installation, drainage, external works, interface with the pedestrian subway under construction at Prince Edward Road East and improvement of the walkway within Shek Ku Lung Road Playground. The total site area is about 14 250 square metres. The main contract is scheduled to commence in June 2021 and for completion in June 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 15 January 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 15 January 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 15 January 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
