

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. NL/2020/03—Tung Chung New Town Extension – Major Infrastructure Works in Tung Chung East**. The works mainly include:—

- (a) construction of engineering infrastructure including drainage works, sewerage works (including two sewage pumping stations), waterworks, roadworks (including carriageways, footpaths, cycle tracks and junction improvements), common utility tunnels and landscaping works; and
- (b) construction of associated environmental mitigation works including noise barriers and low-noise road surfacing.

The works are scheduled to commence in mid-2021 and will take about 60 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 26 February 2021. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 26 February 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 26 February 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with one of members being on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one roads and drainage construction contract with an adjusted contract value of not less than HK\$2,500 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents; and
- (ii) in the case of a joint venture tenderer:—
  - (1) the total percentage participation of participant(s) or shareholder(s) who may or may not be the lead participant or major shareholder and is/are contractor(s) included in the List of Approved Contractors for Public Works under the Roads and Drainage Category is at least 40%; and
  - (2) the percentage participation of the lead participant or major shareholder who is not a contractor included in the List of Approved Contractors for Public Works under Roads and Drainage Category is no more than 60%:—

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (confirmed) under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 29 January 2021 to Chief Engineer/Lantau 1, Sustainable Lantau Office, Civil Engineering and Development Department at 13th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
