

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

SITE FORMATION AND INFRASTRUCTURE WORKS FOR
PUBLIC HOUSING DEVELOPMENTS AT POK FU LAM SOUTH

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently the existing zebra crossings and sections of the existing carriageways, footpaths, bus terminus, lay-bys and central medians/traffic islands; and temporarily sections of the existing carriageways, footpaths, lay-bys and central medians/traffic islands within the limit of works area as shown on Plan No. GZ/001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 7024 published on 21 September 2018 and 28 September 2018. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 18 January 2021, all public or private rights in, upon, under or over the existing zebra crossings and sections of the existing carriageways, footpaths, bus terminus, lay-bys and central medians/traffic islands to be permanently closed, shall be extinguished; and from 18 January 2021 to 17 January 2022, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, lay-bys and central medians/traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the widening of sections of Pok Fu Lam Road and Victoria Road, improvement works at a section of Victoria Road and Wah Lok Path, relocation of the existing lay-bys along Victoria Road, modification of the alignment of a slip road from Wah Fu Road to Shek Pai Wan Road, modification of the existing lay-bys at Shek Pai Wan Road, widening of sections of the existing footpaths along Shek Pai Wan Road, construction of single two-lane carriageways with associated footpaths, covered footpaths, lay-bys, central medians/traffic islands, run-ins/run-outs and traffic light controlled pedestrian crossings connecting Kai Lung Wan North Site with the junction of Victoria Road and Pok Fu Lam Road, construction of footbridges, lift towers with associated staircases and traffic light controlled pedestrian crossing at Shek Pai Wan Road, as well as other ancillary works.

This notice will be affixed on or near the affected zebra crossings, carriageways, footpaths, bus terminus, lay-bys and central medians/traffic islands on 15 January 2021.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means,

before the expiration of one year from the date of closure, extinction, modification or restriction:—

Personal Information Collection Statement
