

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2513EM20T Triennial Term Contract for the Maintenance and Repair of, Alterations and Additions to Fire Service Installations for Airport Venues**. The scope of the Works includes provision of routine and/or corrective maintenance works, additions, alterations, replacement and improvement works, for fire service installations at various airport venues. The Contract is scheduled to commence in August 2021 for completion in July 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in Public Works Tender Box situated in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon, Friday, 26 February 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 26 February 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 26 February 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Required qualification/experience stipulated in Stage I Screening

- (1) Contractor shall have completed fire service installation maintenance and repair contracts in or outside Hong Kong with the accumulated awarded contract sum of not less than HK\$25 million within the past 5-year. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and
- (2) Contractor or the lead participant/major shareholder of the joint venture must be a confirmed contractor on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Fire Service Installation (Group II)'.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Fire Service Installation (Group II)' may also submit a tender if they submit a request for participation together with a duly completed application for
