

It is hereby notified that sealed tenders in quadruplicate are invited for **Contract No. 1312EM20T—Triennial Contract for Maintenance and Repair of, Alteration, Addition to, Fire Service Installations in Municipal Venues for the Government of the Hong Kong Special Administrative Region**. The scope of the works includes the maintenance, repair, alterations and additions of fire service installations in the Municipal Venues for the Government of the Hong Kong Special Administrative Region. The Contract is scheduled to commence in September 2021 for completion in August 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 12 March 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 12 March 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 12 March 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Required qualification/experience stipulated in Stage I Screening

- (1) Contractor shall have completed fire service installation maintenance and repair contracts in or outside Hong Kong with the accumulated awarded contract sum of not less than HK\$45 million within the past 5-year. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and
- (2) Contractor or the lead participant/major shareholder of the joint venture must be a confirmed contractor on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Fire Service Installation (Group II)'.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of 'Fire Service Installation (Group II)' may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 19 February 2021 to Mr. LAM Chun-kit, James, Municipal Sector Division, 6th Floor, Electrical and Mechanical Services Department, 3 Kai Shing Street, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tendering closing date.
