## PWP ITEM NO. B084TI PUBLIC TRANSPORT INTERCHANGE AT TAK TIN STREET AND ASSOCIATED ROAD IMPROVEMENT WORKS IN LAM TIN

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. KT29/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) permanent closure and demolition of sections of the existing carriageway, traffic islands, footpath and pedestrian crossings in bus terminus at Tak Tin Street;
- (ii) permanent closure and conversion of sections of the existing traffic islands in bus terminus at Tak Tin Street into carriageway;
- (iii) permanent closure and conversion of sections of the existing pedestrian crossings at Ping Tin Street and in bus terminus at Tak Tin Street into carriageway;
- (iv) permanent closure and conversion of a section of the existing footpath at Ping Tin Street into carriageway;
- (v) permanent closure and conversion of sections of the existing carriageway, traffic island and pedestrian crossing in bus terminus at Tak Tin Street into footpath;
- (vi) permanent closure and conversion of sections of the existing verges at Ping Tin Street and in bus terminus at Tak Tin Street into footpaths;
- (vii) permanent closure and conversion of sections of the existing carriageway and pedestrian crossing in bus terminus at Tak Tin Street into traffic islands;
- (viii) permanent closure and conversion of sections of the existing carriageway, footpath and traffic islands in bus terminus at Tak Tin Street into pedestrian crossings:
  - (ix) permanent closure and conversion of the existing lay-by at Tak Tin Street into mini-bus stand;
  - (x) permanent closure and conversion of a section of the existing footpath at On Tin Street near Nord Anglia International School into lay-by;
  - (xi) permanent closure and conversion of the existing bus stop and a section of the existing carriageway at Ping Tin Street into lay-by;
- (xii) permanent closure and conversion of the existing pedestrian crossing and a section of the existing footpath and carriageway at Ping Tin Street into motorcycle parking spaces;
- (xiii) permanent closure and conversion of a section of the existing carriageway at Ping Tin Street into metered on-street parking spaces;
- (xiv) permanent closure and conversion of the existing on-street mini-bus stand and a section
  of the existing carriageway at Ping Tin Street into bus stops and overnight bus parking
  spaces;
- (xv) temporary closure and reconstruction of sections of the existing carriageways at Ping Tin Street and in bus terminus at Tak Tin Street;
- (xvi) temporary closure and reconstruction of sections of the existing footpath, traffic islands and pedestrian crossings in bus terminus at Tak Tin Street;
- (xvii) demolition and conversion of a section of the existing slope at On Tin Street near Nord Anglia International School into footpath; and
- (xviii) ancillary works including drainage, landscaping works, demolition and conversion of a section of the existing slope at On Tin Street near Nord Anglia International School into retaining wall and reconstruction of a section of the existing slope at On Tin Street near Nord Anglia International School.
