

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1937EM20T—Four-year Term Contract for Installation and Modification of Traffic Light Signals and Traffic Aids Equipment in Hong Kong**. The scope of works includes installation, modification, disassembling, testing and commissioning of traffic light and traffic aids equipment for Hong Kong Island Region, Kowloon Region and New Territories Region including Lantau Island. The Contract is scheduled to commence in April 2021 for expiry in April 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 5 March 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 5 March 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 5 March 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The tenderer shall have completed contract(s) for (i) supply and installation, (ii) modification or (iii) maintenance of traffic light, traffic aids equipment or traffic signal controller with an aggregate contract value of not less than HK\$8.88 million within the past 5-year period immediately preceding the Tender Closing Date specified in the tender notice regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement.
