This Notice was affixed to the above-mentioned land on 28 January 2021. Upon expiration of the notice period at midnight on 28 April 2021, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 29 April 2021.
