It is hereby notified that the undertaking in relation to the sea-bed described in the Schedule below as mentioned in G.N. 7269 published under section 5 on 11 and 18 December 2020 was authorized under section 7 on 8 March 2021.

Any person who considers that he has an interest, right or easement in or over such sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Sea-bed affected

Approximately 10.3 hectares of sea-bed situated at the waters within the Hong Kong International Airport Approach Area No. I as delineated and shown edged red on a plan, numbered ISM3146a, deposited in the Land Registry.

Description of the undertaking and the manner in which the sea-bed will be affected by the proposed undertaking

- (i) Deployment of up to 500 artificial reef units on the sea-bed within the Hong Kong International Airport Approach Area No. 1 to provide micro marine habitats as shelters and nursery grounds for the purposes of marine and fisheries resources enhancement.
- (ii) The artificial reefs will be made of durable and non-polluting materials and will be deployed in a manner that the tops of the reefs are at least 4.5 metres below the sea surface at any stage of the tide, leaving sufficient clearance between the artificial reefs and sea surface for safe marine navigation.
- (iii) The artificial reefs will collectively occupy a footprint of approximately 0.3 hectare.

Personal Information Collection Statement
