

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1117EM21T, Triennial Term Contract for the Comprehensive Maintenance and Repair of Lift Installation at Various Premises of the Government of the Hong Kong Special Administrative Region (Package One of AE21)**. The scope of the Works includes comprehensive maintenance and repair of lift installation at various premises of the Government of the Hong Kong Special Administrative Region. The Contract is scheduled to commence in July 2021 for expiry in June 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5th Floor, Low Block, The Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 23 April 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 23 April 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon, on Friday, 23 April 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Open tendering is adopted. All interested Contractors who meet the following requirements are invited to tender:—

- (A) A tenderer shall be a registered lift contractor under the Lifts and Escalators Ordinance (Chapter 618 of the Laws of Hong Kong); and  
(B) A tenderer shall have completed lift maintenance contracts in or outside Hong Kong, within the past 5 years counting back from and including the original date set for the close of tender (regardless of any subsequent extension), with the minimum accumulated awarded contract sum of not less than HK\$45 million; and  
(C) A tenderer must not have any consecutive adverse reports on performance in any EMSTF's contracts, on-going or completed, with the last day of the reporting period as specified in the report falling within the 9-month assessment period.
