Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the tender with the highest combined score for a tender adopting a marking scheme or any tender, and reserves the right to negotiate with any tenderer about the terms of its offer.
