TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of existing carriageways and footpaths of Sha Ling Road and Man Kam To Road within the limit of works area as shown on Plans Nos. 231448/GAZ-A/001, 231448/GAZ-A/002 and 231448/GAZ-A/003 (except limit of works area of Sha Ling Road and Man Kam To Road adjoining the proposed Road C shown on the Plan) ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 231448/GAZ-A/101 to 231448/GAZ-A/103 ('the Amendment Plans') and described in the amendment scheme annexed thereto, and as further amended by Second Amendment Plans Nos. 231448/GAZ-A/201, 231448/GAZ-A/203 and 231448/GAZ-A/LEGEND ('the Second Amendment Plans') and described in the second amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 1834 published on 27 February 2015 and 6 March 2015. The Amendment Plans and amendment scheme were referred to in G.N. 9724 published on 18 December 2015 and 24 December 2015. The Second Amendment Plans and second amendment scheme were referred to in G.N. 5653 published on 27 July 2018 and 3 August 2018. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 13 April 2021 to 12 April 2022, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve reconstruction of sections of carriageways and footpaths and other ancillary works.

A copy of the order, the Plans, the Amendment Plans and the Second Amendment Plans may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageways and footpaths on 9 April 2021.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
