

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS K511—Design and Construction of Fire Station and Ambulance Depot with Departmental Accommodations in Lok Ma Chau Loop (Programme No. 178BF)**.

The works include the design and construction of Fire Station and Ambulance Depot with Departmental Accommodations at the north-eastern part of the Lok Ma Chau Loop, comprising a divisional fire station and ambulance depot (with a 10-bay appliance room) and divisional training facilities, a maintenance store for the equipment of the Hazardous Materials (HazMat) Team, a breathing apparatus room, law enforcement facilities for the Dangerous Goods (DG) Division, DG stores, dangerous goods vehicles (DGV) detention areas and laboratories for the Government Laboratory (GL) with ancillary offices, together with associated building services installations, drainage and external works. The construction floor area is approximately 15 000 square metres and the site area is approximately 5,000 square metres. The contract is scheduled to commence in January 2022 and for completion in March 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 2 July 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 2 July 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 2 July 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C for Buildings Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the above-mentioned approved list/category/group who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (1) The tenderer or the lead participant/major shareholder in a joint venture tenderer is a contractor on the List of Approved Contractors for Public Works in Group C for Buildings Category; and
- (2) The tenderer or any one of the participants/shareholders in a joint venture tenderer must have completed at least one building contract in Design and Build arrangement, in Hong Kong or any place outside Hong Kong with an adjusted original contract sum not less than HK\$350 million with building services installations (including plumbing and drainage) not less than HK\$70 million and the substantial completion date within the past 10 years counting from and including the original date set for the close of tender (i.e. between 3 July 2011 and 2 July 2021). Only such contracts with substantial completion date falling within the above stated period will be considered.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by 4 May 2021 to Chief Quantity Surveyor/2 of Quantity Surveying Branch, Architectural Services Department, 33rd Floor, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
