EP/SP/116/19 Provision of Recyclable Food Waste Collection Services—Kowloon District

The service scope comprises provision of collection services of source separated food waste from Food Waste Collection Points (FWCPs) to the OYPARK1 at 5 Sham Fung Road, Siu Ho Wan, North Lantau Island, N.T. for treatment. The services are expected to commence in December 2021 and the contract period is two (2) years.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and deposited in the Government Secretariat Tender Box situated at Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon (Hong Kong Time) on Friday, 11 June 2021. Tender must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tender or tender not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is issued, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Friday, 11 June 2021, the tender closing time will be postponed to 12.00 noon (Hong Kong Time) on the first working day after the tropical cyclone signal No. 8 is cancelled, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Friday, 11 June 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. It is the procurement policy of the Environment Bureau to adopt phased approach to launch three Recyclable Food Waste collection services contracts to serve the three territorial regions, namely Hong Kong Island and Islands District, Kowloon; and the New Territories. In order to introduce more competent service providers to operate the Recyclable Food Waste collection services, no single contractor will be allowed to serve more than two regions at the same time.
