Foreshore and sea-bed affected

Approximately 1.16 hectares of foreshore and sea-bed situated to the west of Sham Chung as delineated and shown edged red on a plan, numbered TPM6614, deposited in the Land Registry. Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include demolition of the existing Sham Chung Pier, construction of a new pier and provision of a temporary pier during the composed of a suspended deck founded on piles, a gangway, and a floating platform held in position by piles. It will cover an area of approximately 600 square metres above the sea.
