

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS K525—Construction of Town Park in Area 68, Tseung Kwan O (Programme No. 451RO)**.

The works include construction of town park in Area 68, Tsuen Kwan O comprising a landscape garden, a central pedestrian avenue, children's play area, a bicycle park for children, a bicycle rental kiosk, fitness equipment, a jogging track, two basketball courts, enhancement work to the existing Tseung Kwan O Waterfront Park, re-provision and expansion of the pet garden in Tseung Kwan O Waterfront Park and ancillary facilities, together with drainage works. The site area is approximately 38 820 square metres. The contract is scheduled to commence in December 2021 and for completion in November 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 25 June 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 25 June 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 25 June 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
