

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS K522—Construction of Open Space at Hoi Fan Road, Tai Kok Tsui (Programme No. 442RO)**.

The works include the construction of Open Space at Hoi Fan Road comprising a landscaped garden, a 7-a-side artificial turf football pitch with spectator stands, two basketball-cum-volleyball courts, a multi-purpose lawn, a fitness corner, a Tai Chi area, a children's playground, a jogging track of around 400 metres with fitness stations, a pet garden, a community garden, and ancillary facilities including toilets and changing rooms, a baby care room, a first-aid room, a management office and rain shelters-cum-pavilions with benches. The site area is about 16 553 square metres. The main contract is scheduled to commence in November 2021 and for completion in August 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 2 July 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 2 July 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal [No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 2 July 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
