It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 1374 published under section 5 on 12 and 19 March 2021 was authorized under section 7 on 26 May 2021.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 690 square metres of foreshore and sea-bed situated in West Kowloon as delineated and shown edged red on a plan, numbered KM10527, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Reconstruction of a section of the existing seawall of about 45 metres in length for the purpose of constructing a drainage outfall with an internal diameter of about 2.1 metres at an invert level of about 2.5 metres below Hong Kong Principal Datum.

Personal Information Collection Statement
