This Notice was affixed to the above-mentioned land on 24 June 2021. Upon expiration of the notice period at midnight on 24 September 2021, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 25 September 2021.
