SCHEDULE

Foreshore and sea-bed affected

Approximately 1.66 hectares of foreshore and sea-bed situated to the west of Sam Mun Tsai as delineated and shown edged red on a plan, numbered TPM6622, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include reconstruction and extension of the existing Sam Mun Tsai Village Pier and provision of a temporary pier during the construction stage. The proposed extension of pier will be composed of a suspended deck founded on piles, a gangway and a floating platform held in position by piles, covering an area of approximately 800 square metres above the sea.
