Foreshore and sea-bed affected

Approximately 31 500 square metres of foreshore and sea-bed situated in the southwest of Tai O as delineated and shown edged red on a plan, numbered ISM3213, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Construction of a new pier which will cover an area of approximately 1 200 square metres above the sea.
