### PREVENTION AND CONTROL OF DISEASE (COMPULSORY TESTING FOR CERTAIN PERSONS) REGULATION

#### **Compulsory Testing Notice**

I hereby exercise the power conferred on me by section 10(1) of the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (*the Regulation*) (Chapter 599, sub. leg. J) to:—

#### Category of Persons

(I) specify the following category of persons [Note 1]:----

- (a) any person who had been present on the following premises in any capacity (including but not limited to full-time, part-time and relief staff, students and visitors) for more than 2 hours at any time during the period from 25 November to 8 December 2021:—
  - (1) Kwai Shing Rhenish Church Kindergarten, No. G1, G/F, Shing Kwok House, Kwai Shing East Estate, Kwai Chung, New Territories, Hong Kong;
  - (2) Lai King Rhenish Nursery, 1/F, Yeung King House (Block 5), Lai King Estate, Kwai Chung, New Territories, Hong Kong;
- (b) students of the schools (*the Specified Schools*) at the levels (*the Specified Levels*) specified below and teachers (including but not limited to full-time, part-time and relief teachers) of the Specified Schools who had face-to-face lesson(s) with such students at the Specified Levels during the period from 25 November to 8 December 2021:—
  - (1) Year 3 of Kowloon Junior School, 20 Perth Street, Ho Man Tin, Kowloon, Hong Kong;
  - (2) Year 2 of Discovery College, 38 Siena Avenue, Discovery Bay, Lantau Island, New Territories, Hong Kong;
- (c) any person who had been present at Plaza Premium Lounge (Near Gate 1, Departure Hall), Level 6, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 9:00 a.m. to 1:00 p.m. on 22 November 2021;
- (d) any person who had been present at Grand Hyatt Hong Kong Grand Ballroom, Lobby Level, Grand Hyatt Hong Kong, 1 Harbour Road, Wan Chai, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 6:00 p.m. to 10:00 p.m. on 21 November 2021;
- (e) any person who had been present at Planet J Hong Kong, 9/F, Times Square, 1 Matheson Street, Causeway Bay, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 2:00 p.m. to 5:00 p.m. on 21 November 2021;
- (f) any person who had been present at Jasmine, 8/F, Windsor House, 311 Gloucester Road, Causeway Bay, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 10:00 a.m. to 11:00 a.m. on 20 November 2021;
- (g) any person who had been present at Galaxy, Shop 2, B1/F, Auto Plaza, 65 Mody Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 10:00 p.m. to 11:59 p.m. on 19 November 2021;
- (h) any person who had been present at Kyoto Joe, 23/F, California Tower, 30–36 D'Aguilar Street, Lan Kwai Fong, Central, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 12:00 noon to 2:00 p.m. on 19 November 2021;

- (i) any person who had been present at IPPUDO, Shop F04–F06, 1/F, Lab Concept, Queensway Plaza, 93 Queensway, Admiralty, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 7:00 p.m. to 9:00 p.m. on 18 November 2021;
- (j) any person who had been present at IL COLPO, Shop 220, Level 2, Pacific Place, 88 Queensway, Admiralty, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 7:00 p.m. to 8:00 p.m. on 18 November 2021;
- (k) any person who had been present at Lions Kitchen, M/F & G/F, 21 Wing Hing Street, Tin Hau, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 6:00 p.m. to 9:00 p.m. on 17 November 2021;
- (l) any person who had been present at Yan Toh Heen, Lower Level, InterContinental Hong Kong, 18 Salisbury Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 12:00 noon to 2:00 p.m. on 16 November 2021;
- (m) any person who had been present at Po Shan Mansion, Kao Shan Terrace, Taikoo Shing, 1 Taikoo Shing Road, Quarry Bay, Hong Kong in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from 16 November to 8 December 2021;
- (n) any person who had been present at Plaza Premium Lounge (Near Gate 60, Departure Hall), Level 7, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 8:00 p.m. to 11:00 p.m. on 20 November 2021;
- (o) any person who had been present at Ki's Roasted Goose, G/F, Man Man Mansion, 45 Jardine's Bazaar, Causeway Bay, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 2:00 p.m. to 4:00 p.m. on 20 November 2021;
- (p) any person who had been present at Hong Kong Central Library, 66 Causeway Road, Causeway Bay, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 2:00 p.m. to 3:00 p.m. on 20 November 2021;
- (q) any person who had been present at Yuen Kee Restaurant, Shop 6–10, G/F Wing Lee Building, 27–31 Kimberley Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 6:00 p.m. to 8:00 p.m. on 19 November 2021;
- (r) any person who had been present at CHIC PRIVATE i SALON, Shop 282–283, L2, Mira Place 2, 118–130 Nathan Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 3:00 p.m. to 7:00 p.m. on 19 November 2021;
- (s) any person who had been present at Yuen Long Bistro, Shop A2, G/F, China Insurance Building, 48 Cameron Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 1:00 p.m. to 4:00 p.m. on 19 November 2021;
- (t) any person who had been present at Ido Legend, 22/F, Cameron Plaza, 23–25A Cameron Road, Tsim Sha Tsui, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 12:00 noon to 2:00 p.m. on 19 November 2021;
- (u) any person who had been present at Men Wah Bing Teng, Shop G1008 & G1009, G/F, Wai Sing Mansion, Sing Fai Terrace, Taikoo Shing, 12 Taikoo Shing Road, Quarry Bay, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 9:00 a.m. to 11:00 a.m. on 16 November 2021;

- (v) any person who had been present at Dr Mok Wong Wai Dental Clinic, Unit 1114, 11/F, Pioneer Centre, 750 Nathan Road, Mong Kok, Kowloon, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 10:00 a.m. to 2:00 p.m. on 17 November 2021;
- (w) any person who had been present at Male Changing Room, LG/F, Marina Wing, Hong Kong Ocean Park Marriott Hotel, 180 Wong Chuk Hang Road, Aberdeen, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 12:00 noon to 2:00 p.m. on 17 November 2021 or from 11:00 p.m. to 11:59 p.m. on 17 November 2021;
- (x) any person who had been present at Staff Canteen, G/F, Marina Wing, Hong Kong Ocean Park Marriott Hotel, 180 Wong Chuk Hang Road, Aberdeen, Hong Kong in any capacity (including but not limited to full-time, part-time and relief staff and visitors) at any time during the period from 3:00 p.m. to 5:00 p.m. on 17 November 2021;

#### **Requirements and Procedure for the Test**

- (II) require every person who falls within the above category to undergo a polymerase chain reaction-based nucleic acid test for the coronavirus disease 2019 (*the Specified Test*) in compliance with the requirements and procedure set out below <sup>[Note 2]</sup>:—
  - (a) for a test at mobile specimen collection stations:-
    - (i) attend one of the mobile specimen collection stations <sup>[Note 3]</sup> set up by the Government on or before 10 December 2021;
    - (ii) undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the stations; and
    - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

<u>OR</u>

- (b) for a test at Community Testing Centres:---
  - (i) attend one of the Community Testing Centres <sup>[Note 4]</sup> set up by the Government on or before 10 December 2021 during its opening hours;
  - undergo the Specified Test, including providing a sample taken through combined nasal and throat swabs, in accordance with the instructions given by the staff at the centre; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (c) for a test using a specimen bottle distributed to the places specified in Part (I) above by the Centre for Health Protection (*CHP*) (only applicable to persons who fall within the category specified in Part (I)(a) above):—
  - (i) obtain a specimen bottle from the CHP;
  - (ii) collect relevant sample (which must not be deep throat saliva sample) in the aforesaid specimen bottle as per the guidelines in the specimen collection pack;
  - (iii) return, by 12 December 2021, the specimen bottle with the sample to one of the designated collection points <sup>[Note 5]</sup>; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

- (d) for a self-arranged test:---
  - (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on https://www.coronavirus.gov.hk/pdf/List\_of\_recognised\_laboratories\_RTPCR.pdf and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, by 10 December 2021, the Specified Test in accordance with the instructions given by the staff of the laboratory, including providing a sample taken through combined nasal and throat swabs; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test, and provide the relevant SMS notification for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;
- (III) require every person who falls within the above category to take appropriate personal disease prevention measures as far as reasonably practicable, including wearing a mask and maintaining hand hygiene; and unless for the purpose of undergoing the Specified Test, stay at his/her place of residence and avoid going out until the test result is ascertained as far as possible;

### Period Specified for the Purpose of Section 14(3)(b) of the Regulation

(IV) specify in relation to the category of persons in Part (I) above the 30-day period from 11 December 2021 to 9 January 2022 or the 30-day period from the day following the Extended Testing Period due to Inclement Weather <sup>INote 6</sup> as the period during which a Compulsory Testing Order may be issued under the Regulation upon non-compliance with this Notice; except for the category of persons in Part (I) above who had undergone the Specified Test in accordance with the requirements and procedure as specified in Part (II)(c) above, the corresponding 30-day period for whom is from 13 December 2021 to 11 January 2022 or the 30-day period from the day following the Extended Testing Period due to Inclement Weather <sup>INote 6</sup>;

# Appointment of Prescribed Officers

(V) appoint members of the Auxiliary Medical Service and all public officers of the Government of the Hong Kong Special Administrative Region to perform a function under the Regulation concerning a requirement specified under this Notice <sup>[Note 7]</sup>.

#### Note 1:-

If a person who falls within the category specified in Part (I) above has previously undergone the Specified Test (in compliance with the requirements and procedure (except the relevant testing deadlines) set out in Part (II) above or Note 2 below) during the period from 6 December to 8 December 2021, he/she would be taken to have complied with the requirements set out in this Notice regardless of whether or not the test was conducted for complying with this Notice.

The category of persons specified in Parts (I)(a) and (I)(b) do not include a person who has completed a COVID-19 vaccination course. For both the Sinovac COVID-19 vaccine (*CoronaVac vaccine*) and Fosun Pharma/BioNTech COVID-19 vaccine (*Comirnaty vaccine*), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before 26 November 2021, except for persons previously infected with COVID-19 who are to receive one dose of vaccine at least 14 days ago, i.e. having received the first dose of COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before 26 November 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for specified purposes as published on https://www.coronavirus.gov.hk/pdf/list\_of\_recognised\_covid19\_vaccines.gov.h

OR

### Note 2:---

If a person who falls within the category specified in Part (I) above is issued a medical certificate by a registered medical practitioner (*relevant medical certificate*), proving that he/she is unfit to undergo the Specified Test using a sample taken through combined nasal and throat swabs in compliance with the requirements and procedure set out in Part (II) because of health reasons, then he/she may undergo the Specified Test using a deep throat saliva sample in compliance with the requirements and procedure set out below:—

- (a) for a test with a specimen bottle obtained:—
  - (i) obtain a specimen bottle from one of the 121 post offices, 47 general out-patient clinics of the Hospital Authority or vending machines set up at 20 MTR stations [Note 5];
  - (ii) collect deep throat saliva sample in the specimen bottle as per the guidelines provided together with the specimen bottle;
  - (iii) return, by 10 December 2021, the specimen bottle with the sample to one of the designated collection points  $^{[Note 5]}$ ; and
  - (iv) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

OR

- (b) for a test at general out-patient clinics of the Hospital Authority:-
  - undergo, by 10 December 2021, the Specified Test at general out-patient clinics of the Hospital Authority as instructed by a medical professional of the Hospital Authority; and
  - (ii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test;

# OR

- (c) for a self-arranged test using deep throat saliva sample:—
  - (i) arrange for the carrying out of the Specified Test at a laboratory which is included in the list of recognised laboratories for the Specified Test published at the coronavirus disease 2019 thematic website on https://www.coronavirus.gov.hk/pdf/List\_of\_recognised\_laboratories\_RTPCR.pdf and which can issue SMS (mobile phone text message) notifications in respect of test results;
  - (ii) undergo, by 10 December 2021, the Specified Test in accordance with the instructions given by the staff of the laboratory; and
  - (iii) keep the SMS (mobile phone text message) notification containing the result of the test and the relevant medical certificate, and provide the relevant SMS notification and relevant medical certificate for checking by a prescribed officer when the prescribed officer requires the person to provide information about his or her undergoing the Specified Test.

### Note 6:-

If the tropical cyclone signal No. 3 or above is hoisted, or a red/black rainstorm warning signal or "extreme conditions after super typhoons" announced by the Government is/are in force at any time during the period for undergoing the Specified Test, the period for undergoing the Specified Test will be extended for 1 day (*the Extended Testing Period due to Inclement Weather*).

# Note 7:-

Under the Regulation, health officers may, without the need of an appointment, perform a function concerning a requirement under a Compulsory Testing Notice.
