

## FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

(Notice of authorization under section 9)

PUBLIC WORKS PROGRAMME ITEM NO. 5060TF IMPROVEMENT WORKS AT  
MA WAN CHUNG PIER

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 3536 published under section 5 on 11 and 18 June 2021 was authorized under section 7 on 6 September 2021.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

## SCHEDULE

*Foreshore and sea-bed affected*

Approximately 5 840 square metres of foreshore and sea-bed situated in the western part of Ma Wan Chung on Lantau Island as delineated and shown edged red on a plan, numbered ISM3229, deposited in the Land Registry.

*Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking*

Works include demolition of the existing Ma Wan Chung Pier, construction of a new pier and provision of a temporary pier during the construction stage. The proposed new pier will cover an area of approximately 280 square metres above the sea.

## Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes.
