

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1420EM21T, Triennial Term Contract for Building Services Fitting-Out, Replacement and Improvement Works for Hospital Authority Building, Kowloon Hospital, Hong Kong Children's Hospital and Nearby Health Services Venues**. The scope of the Works includes building services fitting-out, replacement, addition, alteration and improvement works for Hospital Authority Building, Kowloon Hospital, Hong Kong Children's Hospital and nearby health services venues operated by Hospital Authority and Department of Health in Kowloon Central Region. The Contract is scheduled to commence in May 2022 for expiry in April 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503 on the 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 29 October 2021. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Signal Warning No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 29 October 2021, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Signal Warning No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon, on Friday, 29 October 2021, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
