

**ELECTORAL AFFAIRS COMMISSION (NOMINATIONS ADVISORY  
COMMITTEES (LEGISLATIVE COUNCIL)) REGULATION**  
**(Cap. 541C)**

Pursuant to sections 2(2), 2(3), 2(5), 3(3), 3(4), 5(4), 5(5) and 6(3) of the Electoral Affairs Commission (Nominations Advisory Committees (Legislative Council)) Regulation ('the Regulation'), the following notices are given —

**I. Appointment of Nominations Advisory Committees (Legislative Council)**

The following legal practitioners are each appointed as a Nominations Advisory Committee (Legislative Council) ('NAC(LC)') for the period from 30 September 2021 to 16 November 2021 (both dates inclusive) in relation to the Legislative Council General Election which consists of elections in respect of the ten geographical constituencies, the 28 functional constituencies and the Election Committee constituency, all to be held on 19 December 2021 with the same nomination period from 30 October 2021 to 12 November 2021 —

**II. Periods in which each NAC(LC) must perform its functions**

Each NAC(LC) is to perform during the following periods the functions specified under section 3(1) of the Regulation —

- (a) Between 30 September 2021 and 3 November 2021, to perform functions on applications by prospective candidates to seek advice and to complete the same by 3 November 2021.
- (b) Between 30 October 2021 and 16 November 2021, to perform functions on applications by Returning Officers to seek advice and to complete the same by 16 November 2021.

### **III. Periods in which applications for advice from the NAC(LC) are to be made**

- (a) Applications under paragraph II(a) above must be made in the specified form and lodged with the Chief Electoral Officer in person, by post or by facsimile transmission, to be received by that Officer between 30 September 2021 and 27 October 2021 (both dates inclusive).
- (b) Applications under paragraph II(b) above must be in writing and lodged with the Chief Electoral Officer, to be received by that Officer between 30 October 2021 and 15 November 2021 (both dates inclusive).

The specified form mentioned under paragraph III(a) above can be obtained free of charge during ordinary business hours on any day between 30 September 2021 and 27 October 2021 (except general holidays) from any District Office, or from the Registration and Electoral Office at 10th Floor, Harbour Centre, 25 Harbour Road, Wan Chai, Hong Kong, or can be downloaded from the website of the Registration and Electoral Office (<http://www.reo.gov.hk>).
