TAKE NOTICE that under powers delegated by the Chief Executive, I have made an order under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL), to close temporarily sections of the existing at grade carriageways, at grade footpaths, verges and open spaces within the limit of works area as shown on Plans Nos. 60534575/GAZ_358/101, 60534575/GAZ_358/102 and 60534575/GAZ_358/103 (the 'Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 7229 published on 29 September 2017 and 6 October 2017. I have further declared under section 17(1)(c) of the Ordinance that from 1 February 2022 to 31 January 2023, all public or private rights in, upon, under or over sections of the above existing at grade carriageways, at grade footpaths, verges and open spaces to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during the period.

The sewerage works to be carried out on the above affected existing at grade carriageways, at grade footpaths, verges and open spaces mainly involve:—

- (i) construction of about 1 700 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plans; and
- (ii) ancillary works including reinstatement of at grade carriageways, at grade footpaths, verges and open spaces.

A copy of the order and the Plans showing the above affected existing at grade carriageways, at grade footpaths, verges and open spaces may be inspected by members of the public, free of charge, at the following locations and during the following hours when those offices are normally open to the public:—
