The Protected Information provided is taken from documents filed with the Registry. The Registry shall not be liable for the provision of any incorrect or incomplete information due to any cause whatsoever and shall not be liable for any losses, fees, costs, expenses, damages and liabilities suffered or incurred as a result thereof.

Communication

8.

Notices to be given and reports to be provided to the Applicant shall be sent by email to the email address provided to the Registrar by the Applicant in this application.

Governing Law

9.

The terms and conditions herein shall be governed by the laws of the Hong Kong Special Administrative Region.
