

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS L516—Construction of Refuse Collection Point and Recycling Store at Site G5, Development of Anderson Road Quarry Site, Sai Kung (Programme No. 007NR)**.

The works include the construction of a 3-storey building of overall height approximately 20 metres at Site G5, Development of Anderson Road Quarry Site, Sai Kung comprising refuse collection point, recycling store and ancillary facilities, together with foundation works, building services installations, drainage and external works. The construction floor area is approximately 1 930 square metres. The main contract is scheduled to commence in February 2023 and for completion in February 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503 on the 5th Floor, Low Block of the Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 19 August 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 19 August 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 19 August 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
