The number of contractors invited to submit tenders for the contract may be limited, with the list of contractors invited to tender being at the sole discretion of the HA. Selected contractors will then be formally invited separately to tender.

Failure to respond to the invitation, to collect the tender documents and/or to submit a tender in compliance with tender conditions will be considered as a tendering irregularity and the contractors concerned may be subject to appropriate regulatory actions.
