## SCHEDULE

## Foreshore and sea-bed affected

Approximately 1.0 hectare of foreshore and sea-bed situated in Ping Chau, New Territories as delineated and shown edged red on a plan, numbered TPM6767, deposited in the Land Registry. Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include renovation and extension of the existing Tung Ping Chau Public Pier and provision of a temporary pier during the construction stage. The proposed extension will be composed of a deck founded on piles, a gangway, and a floating platform held in position by piles, covering an area of approximately 595 square metres above the sea.
