Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plans Nos. 278463/SW/GZ/100 to 114 and Resumption Plan No. YLM10745 (Sheet 1 to 6) (the 'Plans') and described in the scheme annexed thereto. The Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) construction of about 13 900 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plans;
- (ii) construction of about 4 000 metres of twin rising mains and associated manholes within the limit of works area as shown on the Plans;
- (iii) construction of four sewage pumping stations and an effluent polishing plant within the limit of works area as shown on the Plans;
- (iv) demolition of about 800 metres of gravity sewers and associated manholes along Road D1 and Road P1 within the limit of works area as shown on the Plans;
- (v) construction of about 400 metres of emergency discharge pipes within the limit of works area as shown on the Plans; and
- (vi) ancillary works including temporary closure and reinstatement of carriageways, footpaths, accesses, cycle tracks, central reserves/refuge islands/traffic islands, amenity areas/verges and run-ins/run-outs or parts thereof.
