## CREATION OF RIGHTS OF TEMPORARY OCCUPATION OF LAND FOR AIRPORT CITY LINK OUTSIDE AIRPORT ISLAND

TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 15(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') directing that rights of temporary occupation of the portion of land known and registered in the Land Registry as Chek Lap Kok Lot No. 2 (the said portion of land is hereinafter referred to as 'the said land') at such levels and location as indicated and shown coloured purple stippled black and coloured yellow on Plan No. ISM3260a annexed to the said order be created for a period from 21 January 2023 to 24 July 2025, which the said land was described in the scheme referred to in Government Notice No. 5504 published on 10 September 2021 and 17 September 2021 (hereinafter referred to as 'the said scheme'), in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or the use described in the said scheme.
