

## FORESHORE AND SEA-BED (RECLAMATIONS) ORDINANCE (Chapter 127)

(Notice of authorization under section 9)

**PROPOSED INSTALLATION OF CHEUNG CHAU CABLE SYSTEM  
FROM TAI LONG WAN TO PAK TSO WAN  
IN THE HONG KONG SPECIAL ADMINISTRATIVE REGION WATERS**

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 4202 published under section 5 on 5 and 12 August 2022 was authorized under section 7 on 25 October 2022.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

## SCHEDULE

### *Foreshore and sea-bed affected*

Approximately 2 200 square metres of foreshore and sea-bed from Tai Long Wan to Pak Tso Wan, as delineated and shown by a bold red line on a plan, numbered ISM3220b, deposited in the Land Registry.

*Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking*

- (i) Installation of an optical fibre submarine cable of approximately 4.4 kilometres in length and 60 millimetres in diameter.
- (ii) A cable-laying barge will be employed to simultaneously lay and bury the submarine cable in a trench of about 0.5 metre in width at a target burial depth of about 3 to 5 metres below the sea-bed. For the cable section approaching the landing sites where the foreshore is rocky, the cable will be installed by diver(s) and protected by articulated pipe.

#### Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Departmental Personal Data Controlling Officer of Lands Department at 21st Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong.
