CREATION OF RIGHTS OF TEMPORARY OCCUPATION OF LAND FOR PROPOSED ROAD WORKS FOR QUEENSWAY PLAZA REDEVELOPMENT (INCORPORATING PWP ITEM NO. 7F38TB—PROPOSED WORKS FOR CONNECTING THE TAMAR FOOTBRIDGE (HIGHWAYS STRUCTURE NO. TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 15(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') directing that rights of temporary occupation of the portions of land known and registered in the Land Registry as Inland Lot No. 8423 (such portions of land are hereinafter collectively referred to as 'the said land') only at such levels and locations as indicated and shown coloured purple and marked Reference Nos. 1 to 4 and Nos. 18 to 19 on Plan No. HKM10383 annexed to the said order be created for a period from 2 March 2023 to 30 September 2024, which the said land was described in the scheme referred to in Government Notice No. 5376 published on 25 September 2020 and 30 September 2020 (hereinafter referred to as 'the said scheme'), in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or the use described in the said scheme.

The Deputy Director/Specialist, Lands Department has under section 15(3) of the Ordinance further directed that subject to the serving of any notice required to be given under section 15(5) of the Ordinance, the Government, its contractors, employees, servants, agents, licensees and any other persons authorized or permitted by the Government shall be authorized to enter upon the said land for the purposes of carrying out any operations or installing, maintaining or removing any structures or apparatus in connection with the said scheme.

It is hereby declared that upon expiry of that period at midnight on 1 March 2023, the aforesaid rights of temporary occupation shall by virtue of section 15(4) of the Ordinance be created in favour of the Government of the Hong Kong Special Administrative Region for the purposes of or incidental to the works or the use described in the said scheme. The date of creation of the aforesaid rights of temporary occupation shall be 2 March 2023.
