AS22047 **Air Quality Monitoring Stations Contract No. 19—Operation of Tseung Kwan O, North and Southern Air Quality Monitoring Stations**

Tenders are invited for the provision of services for the operation of the three air quality monitoring stations namely Tseung Kwan O, North and Southern for a period of 60 months effective from 1 June 2023 or the Date of Tender Acceptance, whichever is the later, subject to and in accordance with the terms and conditions as set out in the Tender Document.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Government Logistics Department Tender Opening Committee, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of the North Point Government Offices at 333, Java Road, North Point, Hong Kong, before 12.00 noon (Hong Kong Time) on Tuesday, 7 February, 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Tuesday, 7 February, 2023, the tender closing time will be postponed to 12.00 noon (Hong Kong Time) on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon (Hong Kong Time) on Tuesday, 7 February, 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
