Explanatory Note

This Resolution increases various amounts for calculating compensation under the Employees' Compensation Ordinance (Cap. 282), which involve—

- (a) the maximum and minimum compensation for death;
- (b) the reimbursement of funeral expenses and expenses of medical attendance;
- (c) the maximum and minimum compensation for permanent total incapacity;
- (d) the compensation for attention required due to permanent incapacity;
- (e) the minimum amount for calculating monthly earnings;
- (f) the costs of supplying, fitting, repairing and renewing prostheses and surgical appliances; and
- (g) various surcharges.
